City Fire Deputy Chief Rob Edmonds mentioned the city has the equipment to test their own hoses and possibly we can work with them on having the testing done by the city. It would save some expense possibly. FEMA Grant Update: No updates. The LEGACY FOUNDATION GRANT: The fire department was awarded \$2000.00 and it will be used for new harnesses for rope rescue. PIE&G Grant: Tom Spaulding continues to prepare the necessary paperwork for the PIE&G grant.
