Budget Report: Sue Thomson, Clerk: None. Report was given at the March, 2022 year-end meeting of the Board of Trustees.

Correspondence: MTA: Reminder of the spring conference.

Cemetery Report: Continue to search for a sexton and an assistant sexton. WAGES for SEXTON & ASSISTANT SEXTON: Discussion regarding wages that we would be prepared to offer an applicant, it was the general concensus of the board to offer \$14.00 per hour to the Sexton and \$12.00 to the Assistant Sexton. There was no action taken on wages.
